RESOLUTION OF THE

NORTHERN CALIFORNIA INDIAN DEVELOPMENT COUNCIL, INC.

RESOLUTION NO.: 18.01

WHEREAS, the Northern California Indian Development Council, Inc. (NCIDC) is a non-profit membership organization with a primary direct service area of Humboldt, Del Norte, Siskiyou, and Trinity Counties, established to administer programs designed to meet the needs of American Indian people; and

WHEREAS, the Northern California Indian Development Council is formally incorporated in the State of California as a non-profit and has a legally binding set of bylaws established to govern the operation of said corporation; and

WHEREAS, the bylaws detail the process for membership in NCIDC for federally recognized indigenous California Indian tribes and democratically elected Indian-controlled community non-profit corporations based in Humboldt, Del Norte, Siskiyou, and Trinity Counties; and

WHEREAS, the NCIDC bylaws further stipulate that the membership list be updated as required and allowed by the bylaws, and the current membership list shall be documented by resolution and certified by the NCIDC Chair; and

WHEREAS, the bylaws stipulate that the current membership resolution shall be maintained in the membership files of the NCIDC main office, distributed to all current member organizations, and posted on the website at ncidc.org; and

WHEREAS, when changes are made to the membership according to the bylaws, the Council shall void the former membership resolution and pass a new resolution documenting the current membership which shall be posted and distributed to the membership as per the bylaws;
